

DIVISION MEMORANDUM

No.<u>139</u> s. 2020



To: Assistant Schools Division Superintendent
Chief, Curriculum Implementation Division
Chief, School Governance and Operations Division
Heads of Public Elementary and Secondary Schools

- 1. DepEd Order No. 11, s. 2020, which was released last June 15, 2020, provides guidelines on the work arrangements and support mechanisms for non-teaching personnel and officials in all DepEd offices across all governance levels.
- 2. As per the latest IATF Resolution duly approved by President Rodrigo Duterte, Angeles City is now under Modified General Community Quarantine (MGCQ). Item 12 c of DepEd Order No. 11, s. 2020 states that under this classification, "Work in government offices may be at full operational capacity, or under such alternative work arrangements as agencies may deem appropriare in accordance with the relevant rules and regulations issued by the CSC".
- 3. As such, this Office adopts the Four-Day Physically Reporting Workweek and One-Day WFH in order to ensure the continuous delivery of essential services to our clientele.
- 4. This Office emphasizes Item No. 5 of the said DepEd Order:

All DepEd teaching and non-teaching personnel are expected to make themselves available during working hours and to maximize the time spent in the discharge of their duties and responsibilities. They are expected to observe honesty, integrity, and professionalism in the conduct of their duties so that government time, money, and resources are employed and used efficiently, honestly, and economically, to avoid wastage of public funds and resources.

4. Weekly Work Plans and Accomplishment Reports, specifying concrete outputs (especially during WFH) will still be submitted to Unit Heads for purposes of monitoring the performance of all SDO Personnel.

- 5. For purposes of monitoring attendance, Item 28 b of the DO # 11, s. 2020 states: "Personnel reporting for duty, whether on-site or off-site, shall check-in with their immediate supervisor, through the agreed mode of communication, to record their actual time log (in and out); and reflect the same in the **Individual Daily Log and Accomplishment Report.**"
- 6. Item 28 c of the same DepEd Order stipulates that "No record of time log and accomplishment shall mean that no work has been rendered/performed for the day, thus subjecting the personnel to absence.
- 7. In adherence to Item 28 e and f of the DepEd Order, all personnel physically reporting for work will record their attendance (time-in and out) using the logbook and Daily Time Record (DTR) and their own ballpen. Use of biometric machines is highly discouraged to minimize contact.
- 8. Immediate and wide dissemination of the Memorandum is desired.
