

Counseling Case Documentation is one of the foundations in the practice of Counseling that must be standardized. The practitioners must have a common knowledge on the elements of Case Documentation so as to create ease in the referral between practitioners and agreement in the assessment of each individual case. A well-prepared counseling document provides a better picture of what have transpired during sessions and what will be considered in the next sessions while maintaining a common language that is comprehensible to all in the field of counseling practice. The workshop will expose participants in the importance of counseling documentation, the different elements in writing a case document, and the common formats used in compliance with standards set by international organizations.

Individual Psychological Test results have been considered important in the practice of counseling. Psychological Tests Results are comparable to Medical Laboratory Test Results that will provide a practitioner with a clear view of the client's functioning (or a patient's medical condition, in medical practice). The movement for the advancement of evidence-based counseling gave rise to the proper and safe use of psychological test results in counseling. This workshop aims to provide participants on the concept of evidence-based practice. It helps participants to identify top-caliber psychological test materials and in creating a very reliable battery of test in individual

Counselor as Coach or Both?

Counselors are successful if they achieve results; and counselors achieve results by working through and with people.
