CALL FOR PAPERS

Guidelines and Mechanics for the Research Presentation

I. Research Topics / Duration of the Research Endeavor / Review Process

Research outputs to be presented are preferably in line with the conference theme, specifically on: (a) teaching strategies; (b) learning assessment; (c) technology integration; (d) the general education; (e) the professional education; (f) the experiential learning courses; (g) practice teaching; (h) new teacher education programs and specializations; and (i) licensure examination.

Each paper will be reviewed by the Research Committee and will be evaluated based on the criteria such as originality/novelty, technical depth/merit and quality of

Hence, only six (6) abstract entries will be chosen for presentation as part of the convention program. To note, there shall be a single presentation only.

II. Abstract Format

A. The abstract should include the following in a single straight paragraph form:

- - (Include name of researcher, school affiliation, contact number
- 2. Introduction / Rationale
- Methodology
- 4. Results and Conclusions Addition:
- 5.Keywords
- There must be five (5) keywords to be included in the abstract.

References

Use the typeface font of 12 point Arial, Word document format in not more than one page, short-sized bond paper, single-spaced.

The list of accepted research papers and the researchers/presenter will be included in the conference proceedings to be distributed during the conference as part of the kit.

III. Powerpoint Specifics for the Oral Presentation

Each research work shall be presented in no more than 10 minutes and must be supported by a Powerpoint presentation, which will be sent ahead of time via e-mail, together with the abstract and the name/s of author/s. The presenter must limit him/herself to 8 slides only, of which each slide must contain maximum of 10 lines only for clearer visual projection. Hence, due to limited time of presentation, presenters are requested to reduce or limit unnecessary explanations and/or elaborations.

In order to have common / parallel format, the following set of standards is required:

Statistical Treatment, Brief Data Gathering Procedure)

Template 6. Findings, Conclusions and Recommendations

(aligned with the SOP presented in one slide)

Template 7. Outputs of the Study (if Applicable)

IV. Submittal Procedures and Notification to Authors

- (a) Abstracts and powerpoint presentations should strictly follow the specifications indicated in the guidelines and must be submitted to the respective regional chairs, who in concurrent capacity, shall recommend to the respective vice presidents for proper and appropriate endorsement to the PAFTE Board, thru the PAFTE Research Committee Chair, Dr. Elmer B. de Leon at rehmle_je29@yahoo.com or Co-Chairs Dr. Sunny G. Gabinete at sunny_gabinete@hotmail.com and Dr. Romeo M. Daligdig at oem32270@yahoo.com.ph and copy furnished the Executive Secretary Dr. Felina P. Espique and Dr. Milagros L. Borabo. Submission of entries shall not be later than April 15, 2018 thru email add: rehmle_je29@yaho.com.
- (b) In order to provide equal opportunity to as much as many senders, only one (1) entry per sender/author shall be accepted/considered. In case of a team research, at least one of the authors must present the paper during the conference.

- (c) The Research Committee, through its Chair, shall inform the presenters of accepted papers for presentation through email not later than **April 20, 2018**.
- (d) To note, research entries will pass through initial screening of respective regional boards, thru the chairs and the final screening by the Research Committee as endorsed by the VPs.
- (e) Presenters will be awarded certificate of merit for oral presentation and PAFTE medallion.
- (e) Upon acknowledgment of receipt of notice of acceptance, another notice will be sent to the presenters that would contain final reminders, schedules of proceedings and confirmation of attendance in the convention. To note, only those who will be present in the convention shall be included in the paper presentation. Hence, no substitute presenter shall be allowed to present and certificates and medals shall be forfeited.
