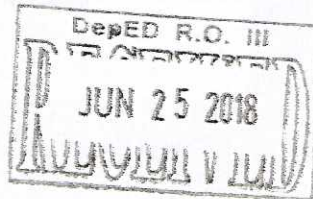

In 2012, the Data Privacy Act (DPA) of 2012 was passed in the Philippines. This law aims to protect the fundamental human right of privacy of communication while ensuring free flow of information to promote innovation and growth. Last September 2016, the final implementing rules and regulations came into force, mandating all companies to comply.

This whole-day event is intended to provide interested participants a better understanding of the DPA and help both individuals and organizations comply with its requirements.
