BASIC TRAINING FOR TEACHERS IN COACHING, OFFICIATING AND COMPETITION MANAGEMENT FOR MARTIAL ART-SPORT OF TAEKWONDO

I Background and Rationale

Taekwondo is one among the sports activity which has been actively played in the Department of Education during the lower meet or Intramural Meet to the highest meet of the nation or the Palarong Pambansa, and played in both elementary and secondary level. Contrary to some doubts and fears that this daring body contact sport may cause harm to the player, the truth is that, it is played with the use of protective gears and guided by the principle of pro player through a well-crafted ground rules following the World Taekwondo (WT) (formerly World Taekwondo Federation/WTF) and World Children Taekwondo Union (WCTU) rules initiated/implemented by a well-trained coaches/trainers and officiating officials thereby making taekwondo sports safe for players. However, even after having known that this sports activity is safe and players are protected, it is still important that coaches, trainers, chaperones, officiating officials and including parents must be equipped with the necessary knowledge, skills and attitude to better help the taekwondo player perform better and build confidence to go for a win and play fairly and squarely.

It is for a fact that a good number of learners in the province, who are taekwondo enthusiasts, and through their private capacity and support of parents are able to pay for their trainings by certified instructors joined in the competitions in Taekwondo conducted by the Department of Education and emerged winners in lower competitions and even went as far as representing the province to competitions to the CLRAA and Palarong Pambansa.

However it has been observed that these taekwondo players are often times endorsed to coaches and chaperons who are untrained in handling them. These Teachers turned outcoaches and chaperons are chosen because the taekwondo player is enrolled in the same schools and these Teacher turned out coaches or chaperons overnight are often times the Sport coordinator or MAPEH Teachers or is the only available personnel in the school and never underwent training and therefore tantamount to mishandle the training and activities of the player.

It is for this reason that the proponent offers a training to all DepEd Teachers who are MAPEH, PESS Coordinators, Sports Coordinators, Coaches and Chaperons and non-MAPEH Majors who are sports enthusiast and are willing to undergo seminar-workshop in taekwondo sport.

II Training Objectives and Expected Outcomes:

This training aims to:

- capacitate the participants on the required Knowledge and basic skills in Taekwondo, from Coaching, Officiating and Competition Management.
- 2. train the participants in proper handling of players during training and competitions
- 3. ensure that correct attitude and behavior in coaching and mentoring is performed.
- ascertain that participants can perform the correct basic techniques and strategies of Taekwondo

III Target Participants:

This Training aims to train all interested Taekwondo enthusiasts from Elementary level to the secondary level in both public and private schools who are MAPEH Teachers, PESS Coordinators, interested Teachers or those who are Taekwondo enthusiasts.

IV Methodology

This training workshop will be conducted for three (3) days. The participants will be identified earlier and a pre-registration will be done. Profiling among the participants will be conducted according to experience as coach or chaperon. The intensity of the training needed will be based on the profile conducted.

The first day and all the days that follows will consists of orientation and all sessions that will follow will involve topics for lectures and discussions, demonstrations by instructor and return demonstration by the participants. The psychology of coaching and mentoring, skill of preparing a training schedule and game plan for the players or ramification, parents involvement will be among the topics to be discussed apart from the leadership and management skills,

Instructors of this training are Licensed International Taekwondo Instructors, International Referees and National Referees.

A Certificate of Participation/Completion will be distributed to participants who completes the whole duration of the training program and exemplified the required skills.
