

2018 Principals' Test

Date : September 18, 2018

1. In consultation with the Bureau of Human Resources and Organizational Development (BHRD), DepEd, Central Office, it is clarified:

- 1.1 In determining qualified applicant to take the Principal Test, **current position shall not be a basis**. It is important that the applicant meets **any one of the experience requirements** for the entire career;
- 1.2 **Aggregated sum of the position**, experience requirement is **not allowed**;
- 1.3 For SEPS and EPS applicants, check Qualification Standard in DepEd Order 39 for Head Teacher, Master Teacher, Teacher 3, SPED, Teacher and Teacher 2 Applicants, check experience requirements in items 4.a to 4.e of the 2018 Principal Test Qualification re: experience requirements;
- 1.3.1 Education Program Specialist and Senior Education Specialist **shall be allowed to take the Principal Test, provided that**, they meet the minimum Qualification Standard for Principal 1 Position stipulated in DepEd Order No. 39, s. 2007 entitled **Modified Qualification Standards for the Position of Head Teachers and Principals**;

1.4 Anticipated revision of Principals' Test 2018 Memo:

1.4.1 Unsuccessful takers/examiners in the Principal Test administered in 2015, 2016, 2017 **shall be given a chance to take the 2018 Principal Test**. However, failure to pass the 2018 Principal Test, he / she shall be required to undergo a specialized preparatory course before applying for the next Principal Test. Guidelines in the implementation of the said intervention shall be issued soon.
