



SUBJECT: **Update on the Status of Online Training for Newly-hired Teachers (DOST Scholars under RA 10612)**

DATE: 23 November 2018

1. Pursuant to Section 12 of the Republic Act 10612 otherwise known as **"Fast-tracked Science and Technology Scholarship Act of 2013"**, the Department of Education through the Teacher Education Council (TEC) in partnership with the Philippine Normal University (PNU) is currently conducting an online training for newly-hired teachers (DOST Scholars under RA 10612).
2. The PNU as the National Center for Teacher Education and service provider has conducted series of face-to-face orientation in all the regions on the online training which was participated in by newly-hired teachers (DOST Scholars under RA 10612). Through this online course, newly-hired teachers will be credited 18 units for them to take the Board Licensure Examinations for Teachers (*for non-BLEPT passers*) or they will be given Continuing Professional Development (CPD) Credit Units (*for BLEPT passers*).
3. The TEC, DOST, and PNU conducted a meeting on the status of the said online training. Out of 673 who were in the master list, only 550 attended or 82 % attended the face-to-face orientation. Sixty Four (64) teachers who were not in the list, but showed proof that they are scholars of RA 10612 came to the orientation. A total of 614 teachers are expected to attend the online training. Based on the progress report presented by the service provider, only 193 out of 614 or 31% of newly-hired teachers are active in the online training. 1. The online training is composed of six (6) modules/courses, namely: a) Foundations of Education, b) Psychology of Learning, c) Introduction to Curriculum Development and Instructional Planning, d) Principles and Strategies in Teaching, e) Assessment and Evaluation of Learning, and f) Development of Instructional Materials. The training started on October 27 and will end on May 25, 2019. Module 1 started on October 27, 2018 and will end on November 17. However, due to the significant number of inactive participants in the training, PNU has extended the submission of outputs up to December 16, 2018.
2. In connection with this, all newly-hired teachers who attended the face-to-face orientation but did not pursue the online training are required to submit a letter of explanation stating the reason of their inactive status in the online training. The letter will be sent to the Office of the Schools Division Superintendent and will be forwarded to the Executive Director of the TEC Secretariat.
