



The big challenge therefore is to equip all the athletes, coaches, referees, and other stakeholders with the highest technical interpretation of the rules to perfect the execution of athletes from practice until performance is achieved with excellence in every game. This determines which level are your Referees in the delivery of fair judgment to athletes. This is where we have high regards that your referees can be part of our quest in the 2019 SEAGAMES.

This is why we will need this 3-days regional levelling of R-3 Referees, training them and honing their skills. Hence, the objective of the levelling will:

1. allow referees or even coaches, athletes, enthusiasts to come together as a group to achieve a common direction as Referee for excellence including your Gold performance in your 2019 Palarong Pambansa participation;
2. afford each of your regional Referee justice as to what level of officiating are they really categorized based on international standards;
3. provide common interpretation of the recent 2017 released Law of Sepaktakraw;
4. create a direction of understanding from the viewpoint of the coaches, athletes, referees, and stakeholders;
5. establishing a very attractive atmosphere for the sponsors, benefactors, and spectators of Sepaktakraw, and
6. put substance in our hopes anchored on our failure to reach the Top 5 Overall in the Palarong Pambansa 2018 in Vigan.

Being a self-liquidating activity, a measly P1,500 Registration for the entire 3-days Training Seminar will be asked from each participant who will get a Certificate of Recognition & Appearance, Materials in PDF, and morning and afternoon snacks.
