## COMELEC

#### RULES AND REGULATIONS ON THE 2019 ELECTION OF ACPUSTA OFFICERS

- 1. Certificates of Candidacy must be filed at the ACPUSTA office from July 22 to 23, 2019. Last hour of acceptance is 5:00 p.m.
- 2. Candidates for any position shall submit their School and ACPUSTA clearances together with other pertinent papers for candidacy.
- 3. QUALIFICATION OF CANDIDATES.
  - 3.1 A regular member with a good character.
    - (No existing criminal case)
  - 3.2 No existing ARREARS on the date of election period.
- 4. Rules and regulations on elections shall be reviewed and approved by the COMELEC officers.
- 5. Reviewing and approving the certificate of candidacy by the COMELEC officers will be on July 24, 2019.
- 6. Campaign period shall start on July 25 and end on July 31, 2019.
- 7. Meeting de Avance will be on the afternoon of August 1, 2019.
- 8. Election will be on August 2, 2019 from 8:00 a.m. to 4:00 pm at the AES covered court. (Subject to Change).
- 9. All regular members are qualified to vote.
- 10. Candidates are prohibited to enter the polling place except to vote.
- 11. Qualified voters are divided into 6 groups, to wit:
  - 11.1 North District
  - 11.2East District
  - 11.3West District
  - 11.4South District
  - 11.5Secondary Schools Set A
  - 11.6Secondary Schools Set B
  - 11.7Division Office Personnel, PESPA, PSSPA and Retirees
  - 11.8Each group shall be assigned an Election Booth.
- 12. Each Election Booth is manned by two Election Tellers who will conduct the election processes including the appreciation of ballots which results shall be duly certified by them.
- 13. Voters who on or before the stroke of 4:00 p.m. and are within the polling place shall be allowed to vote.
- 14. Election results per Election Booth will then be recorded and tallied by the COMELEC on the form provided for (Certificate of Canvass).
- 15. Results shall be duly certified by the COMELEC officer with the four members who will be taken from the B.E.T.
- 16. In case of a tie, toss coin shall be done once by the Chairman of the COMELEC.
- 17. The fifty percent plus one of the actual number of votes will be observed for the success of the election.
- 18. Winners shall be proclaimed by the COMELEC chairman right after the certification of results.
- 19. In case of protest, the protestor/s shall file and submit it to the chairman of the COMELEC.
- 20. The decision of the COMELEC shall be final and irrevocable.
