

MABUHAY from the Philippine Center for Gifted Education (PCGE)!

We are again celebrating the National Week for the Filipino Gifted and Talented which was proclaimed by then President Joseph Ejercito Estrada through Proclamation 199 to be the last week of November. The declaration aims to promote the cause of giftedness and talented individuals in the Philippines.

The PCGE which has faithfully celebrated the week, will hold the Annual Conference on Giftedness on November 29 to 30, 2019 at the Rembrandt Hotel, 26 Tomas Morato Extension, Quezon City. The theme for this year is, "Revisiting Multiple Intelligences in Nurturing the Gifted."

As we believe you are aware, the Theory of Multiple Intelligences was developed by Dr. Howard Gardner of Harvard University, and posits that individuals have unique ways of learning, and possess different intelligences which they employ in understanding the world and living their daily lives. Gardner's theory has affected a number of educational initiatives not only in the United States but also in some Philippine schools, and particularly emphasizes the consideration for personalized instruction to address diversity of students' abilities. The gifted children are expectedly among the beneficiaries of such programs.

It is in this context that we wish to bring together attendees from the public and private school teachers. Academe, psychologists, guidance counsellors, paediatricians, other professionals and even the gifted and their parents, to share their experiences and challenges encountered in the various ways that they do to address the needs of the gifted.

This year, we invited DR. NATHAN LEVY as Resource Speaker and Workshop Facilitator. He will be joined by some Filipino gifted persons who have made distinction in the various intelligences as posited in the theory. We believe their insights from their personal experiences may be an important input to be considered in the way schools promote and address their students' varying intelligences.

We believe that this conference will leave valuable thoughts that participants, in their various capacities, may ponder on with the end in view of addressing the needs and interests of diverse learners, in consideration of the mandate of RA 10533 (Section 2C) that, "The State shall make education learner-oriented and responsive to the needs, cognitive and cultural capacity..."
