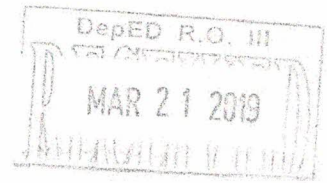
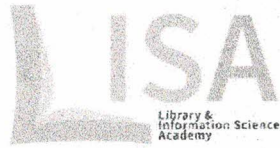

Dr. Bonifacio V. Ramos

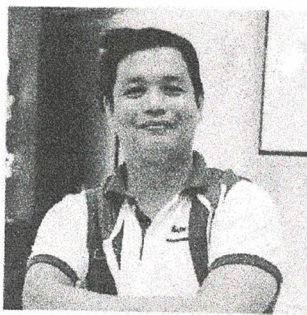
Educator, Librarian, Educational Manager, and Researcher

Dr. Bonifacio V. Ramos is an educator, librarian, educational manager, and researcher. Prior to his present engagement as Director of Libraries of Holy Angel University, Angeles City, Pampanga, he served at Saint Mary's University (SMU), Bayombong, Nueva Vizcaya, in various capacities: faculty member, Director of Libraries, Graduate School Dean, and Research Director. At the same time, he handled other tasks such as being editor of the various university's research publications (*Partuat: Undergraduate students' Research Journal*; *Journal of Northern Luzon*, and *Saint Mary's University Research Journal*). He has written several researches, some of them finding publication in various monographs, journals, and on-line sources. He taught undergraduate and graduate courses in educational management, library and information science and other related fields, and served on many occasions as thesis/dissertation adviser and panel of examiners. Holding a degree of MAEd-Library Science from the Philippine Normal University, EdD-Educational Management from SMU, and post-graduate diploma (Unesco-Post-Graduate Training Course for Science Information Specialists in Southeast Asia at the Institute of Library Science, UP-Diliman), he was the No. 1 Topnotcher in the 1999 Librarian Licensure Examination. He has served as a PAASCU accreditor, Assessor of the CHED-Institutional Sustainability Assessment (ISA) program and its predecessor, Institutional Monitoring and Evaluation for Quality Assurance (IQuaME) in Higher Educational Institutions. Immediately prior to Holy Angel University, he also served as Vice President for Administration and Research Director of PLT College Inc., Bayombong, Nueva Vizcaya. He is presently with the Board of Directors of the Nakem Conferences International (based at UH Manoa, USA) and Nakem Conferences Philippines (based at MMSU, Batac City, IN, Philippines), Secretary of the Consortium of Engineering Libraries of the Philippines (CELPh), a member of the Angeles City Library Board (in his capacity as President of the Friends of the Library), and the President of the Nueva Vizcaya Historical Society. His other interests are mountaineering (being a member of the Sang-at Salug Outdoor Club Inc. of Nueva Vizcaya, an affiliate of the Mountaineering Federation of the Philippines) and biking (being a member of the Bayombong-Solano Bikers' Club). He is happily married, with two (2) children and four (4) grandchildren.

Christian George F. Acevedo graduated Bachelor in Secondary Education at Capiz State University and Master of Library and Information Science at Central Philippine University. This is to certify that the Articles of Incorporation and By-Laws of

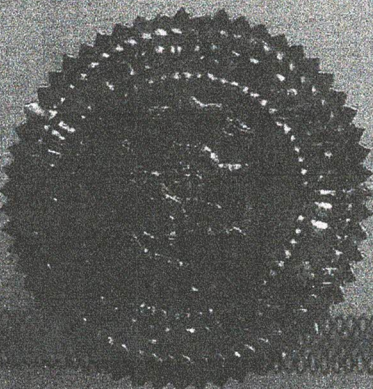
