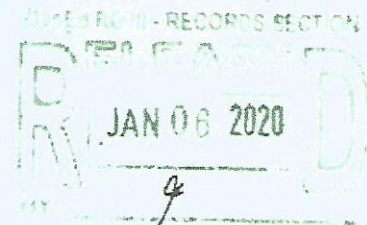


Greetings!
