Attached is the City Social Welfare and Development Office Proposal Letter.

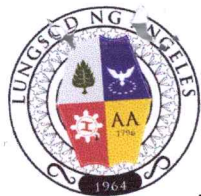

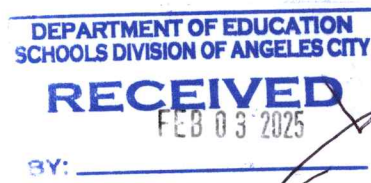

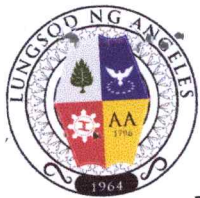
**Subject:** Request for Collaboration and Participation in

This year's theme, **"Stop Online and Offline Abuse and Exploitation of Children.
