- Word limit: must be at least 1,500 words and must not exceed 2,000 words
- Format: Typed, Arial, 12-point font, double-spaced, submitted as a PDF (Oficio 8.5 x 13)
- File name: Essay Entry_[Name of Author]_[Name of School]_[Category].pdf

Criteria for Judging:

30% - Relevance to the Theme
 (How clearly the essay addresses the theme)

20% - Creativity and Originality
 (Unique perspective, voice, and approach)

 20% - Clarity and Organization (Logical structure and flow of ideas)

20% - Insight and Depth (Thoughtfulness and depth of analysis or reflection)

10% - Language and Grammar
 (Proper use of language, grammar, and punctuation)
