 - b. All teacher – applicants must submit on or before April 11, 2014 all the documents specified in DepEd Order No. 14, s. 2014 to the head of elementary or secondary school where a teacher shortage / vacancy exists.
 - c. School Heads must submit all the documents of the applicants to the Division Selection Committee on or before April 16, 2014.
 - d. The Division Selection Committee shall evaluate the documents on April 21-23, 2014.
 - e. The schedule of demonstration and interview of applicants who were not yet interviewed and who have not yet demonstrated is on April 24, 2014 (Elementary) and April 25, 2014 (Secondary) at Angeles City National High School, Pampang, Angeles City from 8:00 AM to 12:00 NN.
