DIVISION LITERARY-MUSICALE

A Theatrical Showcase of Filipino Culture, Heritage and Diversities

- 1. This is to announce to the field the **Division Literary-Musicale Competition**, a theatrical showcase of Filipino Culture, Heritage and Diversities, to be held on December 12, 2014, in line with the week-long celebration of Education Week 2014.
- 2. The competition is for all Public Elementary Schools grouped as follows:

North District

West District

East District

South District

and Secondary Schools clustered as follows:

- Cluster A Rafael L. Lazatin MHS, Sapangbato NHS and Angeles City National Trade School
- Cluster B Francisco G. Nepomuceno MHS, Bonifacio V. Romero HS and Northville 15 IS
- Cluster C Angeles City National HS, Angeles City Science HS, Claro M. Recto ICT HS, Gov. Rafael L. Lazatin IS
- 3. All schools in the group/cluster must have representatives.
- 4. The **mechanics** of the contest are as follows:
 - a. Each group should have a minimum of twenty (20) members and a maximum of thirty (30) members.
 - b. Each group should comprise of the following:

Public Schools District Supervisors (for Public Elementary Schools)

School Heads

Students

Department Heads

Office Personnel

Master Teachers

Parents

- c. All groups will perform a literary-musicale piece with music written by a Filipino composer in any genre (popular, sacred, folk, contemporary)
- d. The order of the performances will be determined by the drawing of lots on the competition day itself.
- e. Each group will be given twenty-five minutes to prepare the stage and to perform the Literary-Musicale piece.
- f. Time starts as the stage is set up and the musical piece is played/sung.
- g. Any group exceeding the maximum time allotment for the performance will be deducted as follows:

More than thirty (30) seconds over time allotment – 1 point deduction One (1) to two (2) minutes over time allotment – 2 points deduction Three (3) to five (5) minutes over time allotment – 5 points deduction

- h. The Board of Judges will be composed of renowned singers, conductors and artistic directors whose literary-musicale background is solid.
- i. Each judge will evaluate the groups on the following criteria:

Technique (Intonation, Diction, Blend and Balance) = 40%

Artistry & Musicality (Interpretation, Expression and Style) = 30%

Stage Performance (Over-all quality and originality of the ideas expressed) = 20%

Stage and Technical Preparation = 100%

j. The judges will utilize the Ranking System to determine the award level as follows:

Diamond Award
High Platinum Award
Platinum Award
Gold Award
Silver Award
Bronze Award
Crystal Award

- k. The DECISION of the Board of Judges is final.
- 5. Immediate and wide dissemination of this memorandum is enjoined.
