IV. Rationale:

The Enhanced Basic Education Program, as stipulated in Republic Act No. 10533 and the IPED provision of its Implementing Rules and Regulations (Sec. 8.4), mandates DepEd to develop a curriculum that is culture-sensitive, contextualized, and flexible enough to enable and allow schools to localize, indigenize, and enhance based on the specific educational and social context of communities.

In support of this mandate, the Division Training-Workshop aims to build the capacity of teachers and school heads in school serving IP learners in indigenizing the basic education curriculum in partnership with indigenous communities. The indigenized curriculum will be the basis for developing indigenized lesson plans which will guide teachers in facilitating a culture-based and culture-responsive teaching-learning process.

The objectives of the project are:

- a) gain and develop the competencies needed in contextualizing the curriculum responsive to the indigenous community being served;
- b) gain and develop the competencies needed in developing lesson plans based on the contextualized curriculum for IPED:
- c) implement a working partnership with the local communities in doing above.

V. Description of the Project

The training-workshop focuses on the synthesized review of the foundational perspective, policies and concepts in implementing the IPED Program. It also discusses the overall thrusts of DepEd towards curriculum contextualization. The different activities and inputs hope to develop the participants' sensitivity and understanding of the IKSPs and ILS and how these are to be curriculum. Developing Indigenized Lesson Plans is the final activity interfaced with the under which all competencies learned are to be applied, the concrete output being indigenized lesson plans.
