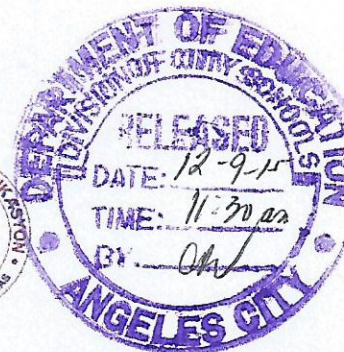
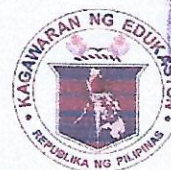

- Each contestant must reflect through their essays the importance of honesty and integrity in forming a person's integrity, especially of those in public offices.

SYSTEM:

- The contest is open to all Tweens, aged 10-12 years, and currently enrolled in any public or private primary school in the country, children or relative of a former or active public official/employee;
- The essay must be in English OR Filipino computer word processed, and must not exceed a maximum of 1000 words;
- The entry must be original, unpublished online or offline, of the sole property of the writer, and has not been previously submitted to any other contest/s.

SCREENING PROCESS:

- The target total number of entries is at least 1,000.
- The initial screening committee will select the top 30 qualified pre-finalists from the total number of entries submitted.
- The final screening committee will select the top 10 finalists from the 30 qualified entries, who will undergo a writing workshop prior to the validation essay writing for the selection of the top three (3) winners.

Relevance to the theme	30%
Creativity	30%
Coherence	20%
Structure & Grammar	20%
