

1. This Office appreciates the intention of Schools Division Offices to conduct Division led Roll-out of the Early Language, Literacy and Numeracy Training and Developmentally Appropriate Practices, however, the said activity is strongly discouraged.
2. Provision 4.1. of DepEd Order No. 12, s. 2015 states that the ELLN training is conducted in three phases: National, Regional and Mentoring through School Learning Action Cells. Thus, the offshoot of the regional training is Mentoring through SLACs and not through a Division roll-out.
3. Immediate dissemination of and strict compliance of this Memorandum is directed.
