

EFFECTIVE STRENGTH AND CONDITIONING RIGID TRAINING FOR THE ANGELES CITY DELEGATION TO THE 2018 (CLRAA) MEET

To: Public Elementary, Secondary and Senior High Schools
Private Elementary, Secondary and Senior High Schools

- 1. The 2018 Central Luzon Regional Athletic Association (CLRAA) Meet is scheduled on February 25 to March 2, 2018 at the Bulacan Sports Complex, Sta. Isabel, City of Malolos, Bulacan.
- The departure of the delegates will be on February 24, 2018 at 12:00 N.N. Division of Angeles City.
- 3. In preparation for the said meet, athletes, coaches and training managers are presently undergoing a live-out effective strength and conditioning rigid training in different training venues every Saturday from January 6, 2018 to February 17, 2018.
- 4. Relative to this, all coaches and training managers are required to adhere to the provisions of DepEd Order No. 40, s. 2012 (DepEd Child Protection Policy). As such, they shall be held responsible for the protection, welfare and safety of their athletes.

5. All concerned schools are expected to extend their full support to their students who

have been selected to participate in the 2018 CLRAA and presently undergoing the training.

In the same manner, they are hereby enjoined to comply with the mandates of Education Act

of 1982, Rule III, Section 3, (e) that teachers shall refrain from making deductions in the

scholastic rating of pupils/students, for any act that is clearly not a manifestation of poor

scholarship and DepEd Order No. 66, s. 2017, Paragraph 2, (b) uphold child protection

policy principles and that no learner shall be disadvantaged in any form.

Likewise, support shall be given by their teachers and make necessary arrangements 6.

in accordance with the DepEd Order No. 9, s. 2005, entitled "Instituting Measures to

Increase Engaged Time on Task and Ensuring Compliance Therewith" and strict compliance

with 180 days Teaching and Learning Guidelines.

7. Service Credits shall be granted as stipulated in DECS Order No. 53, s. 2003 entitled

"Updated Guidelines on Grant of Vacation Service Credits to Teachers. Non-Teaching

personnel shall be entitled to Compensatory Time-Off (CTO) in accordance to Civil Service

Commission and Department of Budget and Management Joint Circular No. 2, s. 2004 on

Non Remuneration for Overtime Service Rendered.
