#### 2019 DRRM Art Mural Contest

#### **Mechanics of the Contest**

#### The Subject

The subject of the context is selecting the best design of a mural, i.e. a large-format wall painting and its execution. The execution of the work falls on the last week of August. The content of the mural must, at the very least, contain information of the following:

- Typhoon/Flood Information and Preparedness Measures (from PAGASA)
- Earthquake Preparedness Measures (from PHIVOLCS)
- Fire Safety and Prevention (from BFP)
- Community Hotline Numbers (from ACDRRMO)

#### Location of the Mural

A side wall (rectangular in shape) with a minimum dimension requirement of 3m x 7m. The mural location should be in a conspicuous place in the campus.

#### **Participation Terms and Conditions**

- The invitation to participate in the contest is addressed to all public schools in Angeles City, disseminated through the Department of Education Schools Division Office. Confirmation slip must be submitted to the SGOD Office on or before August 16, 2019.
- 2. The school shall provide for the material needs in the execution of the mural.
- 3. The Jenra Foundation Inc. logo shall be included in the mural painting. (No specific dimension were required)
- A participating school must follow the minimum information and dimension requirements stated above.
- Participating school should provide a high definition digital copy (JPG format) of the finished mural. Works should be submitted electronically to <a href="mailto:mariacristina.sarmiento@deped.gov.ph">mariacristina.sarmiento@deped.gov.ph</a> on or before August 30, 2019. In the subject of the message should be "2019 DRRM ART MURAL CONTEST".

The entry must contain the following information:

- Name of the participating school
- Name of the School Head and DRRM Coordinator
- Contact No. of the School Head and DRRM Coordinator
- Attached high definition (HD) copy of the mural entry
- 6. A group of judges will conduct an ocular inspection to the participating schools to validate its entry's compliance to the minimum dimension and information requirements.

7. The mural will be judged based on the following criteria:

Criteria for Judging	Rating
Theme Relevance  Does the mural effectively communicate  Disaster preparedness?	40%
Creativity and Originality  Does the mural demonstrate creativity and originality?	30%
Aesthetic Appeal  Does the mural captivate the judge's sense, taking into account the principle symmetry, focal point, pattern perspective, dimensionality and proportion?	30%

 If the participating school failed to meet the minimum dimension and information requirement, point deduction will be applied:

Minus 2 pts – minimum dimension Minus 2 pts – minimum information

#### **Evaluation of Submitted Works**

1. The mural submitted for the contest shall be evaluated in formal terms by the judges appointed by DepEd Angeles City and Jenra Foundation Inc.

2. Decisions of the judges are final and irrevocable. The verdict cannot be appealed.


