- The Department of Education (DepEd), Angeles City has been facilitating an annual collection of data on basic education statistics, and encoding of learners' profile in all public and private schools, SUCs/LUCs offering basic education, and learning centers through the information systems (BEIS and LIS), to ensure the accessibility and availability of the data and information collected for effective and efficient usage in the planning and budgeting particularly in the allocation of resources and setting of operation targets.
- 2. In this regard, the Planning & Research Unit will conduct **Division Orientation on the Policy Guidelines on the Collection of Data Requirements for Beginning of SY 2019-2020 in the BEIS and LIS on August 29 & 30, 2019, 8:00 am at Azzuro Hotel, Balibago, Angeles City**
- The activity aims to:
  - a. Provide guidance to all schools in the conduct of the data collection requirements and online registration learners through the BEIS and LIS respectively;
  - b. Introduce additional and updated data gathering forms designed for uploading data processing using the BEIS;
  - c. Update the schools regarding LIS helpdesk process;
  - d. Address all the issues and requests for data corrections;
  - e. Ensure 100% encoding of all learners before the cut-off date to provide accurate and complete data and information to the different stakeholders for policy formulation.
- 4. Participants are the School Heads and School LIS/BEIS Coordinators (1 per school)
- 5. Expenses relative to the conduct of this Division Orientation shall be charged to BEIS Funds for School BEIS/LIS Coordinators and School MOOE/Canteen for School Heads.
