

- J Except for Aurora, there will be two (2) days schedule of voting per provinces as indicated above.
- K. Voting shall be held as follows:
  - 1. Aurora-September 13, 2019 (Friday), the venue as identified above, starting at 8:00 o'clock in the morning and shall ending at 4:00 o'clock in the afternoon;
  - 2. Zambales-September 19-20, 2019 (Thursday & Friday), and precincts as defined above, starting at 8:00 o'clock in the morning and shall ending at 4:00 o'clock in the afternoon respectively;
  - 3. Bataan-September 3-4, 2019 (Thursday & Friday), and precincts as defined, above starting at 8:00 o'clock in the morning and shall ending at 4:00 o'clock in the afternoon respectively;
  - 4. Pampanga-October 10-11, 2019 (Thursday & Friday), and precincts as defined, above starting at 8:00 o'clock in the morning and shall ending at 4:00 o'clock in the afternoon respectively;
  - 5. Tarlac-October 17-18, 2019 (Thursday & Friday), and precincts as defined, above starting at 8:00 o'clock in the morning and shall ending at 4:00 o'clock in the afternoon respectively;
  - 6. Nueva Ecija- October 24-25, 2019 (Thursday & Friday), and precincts as defined, above starting at 8:00 o'clock in the morning and shall ending at 4:00 o'clock in the afternoon respectively;
  - 7. Bulacan- November 7-8, 20197 (Thursday & Friday), and precincts as defined, above starting at 8:00 o'clock in the morning and shall ending at 4:00 o'clock in the afternoon respectively;
- L. Opening, counting and initial canvassing of votes per province shall be done immediately after the close of the polling in the precinct, or when the last voter has cast its vote, or when the parties as reflected in the Minutes agree to close the casting of votes before the closing period. They shall be done at the said polling place and in the presence of the contending organizations' representatives.
- M. The consolidation of all canvassed votes shall be done on 15 November 2019 (Friday), 2:00 o'clock in the afternoon at the DOLE Region Office No. III, Diosdado Macapagal Regional Government Center, Brgy. Maimpis, City of San Fernando, Pampanga, and in the presence of the contending organizations' representatives.

#### **ELECTION PARAPHERNALIA**

A. <u>Official ballots and official tally sheets.</u> The DESIGNATED ELECTION OFFICER shall prepare the official ballots and the official tally sheets to be used in the certification election.

The Election Officer and one representative each from the participating Unions shall sign or initial at the back of the official ballots. The signing shall be done as follows:

- The contending Union Presidents or their authorized representative together with the Election Officer shall sign the lists of voters and official ballots on 27 August 2019, 9:30 in the morning, at DOLE RO3, CSF, Pampanga.
- If either or both parties failed to attend the scheduled conference for signing of the official ballots despite due notice, the same shall be deemed as a waiver of either or both parties' right to initial the official ballots.
- 3. The names of the contending unions shall be arranged in the ballots as follows:
  - a) ALLIANCE OF CONCERNED TEACHERS REGION III (ACT-ROIII):
  - ACTION AND SOLIDARITY FOR EMPOWERMENT OF TEACHERS-Central Luzon Union (ASSERT);

- c) No union
- B. <u>Ballot boxes and padlocks</u>. ELECTION OFFICER shall provide the ballot boxes. Use of improvised ballot boxes may also be resorted to in case the official ballot box is not available.
- C. <u>Polling booths</u>, etc. The DepEd management shall set-up the polling booths which shall not be less ten (10) but not more than fifteen (15) per polling precinct. Voters are directed to bring their own pens.

## III. ELIGIBLE/QUALIFIED VOTERS

All rank-and-file teaching personnel of the Department of Education (DepEd) of Regional Office No. Ill shall be qualified to vote. Final list of eligible voters shall be signed by the Election Officer, representative of the unions and the Management on 27 August 2019, 9:30 in the morning, at DOLE RO3, CSF, Pampanga.

### IV. GROUNDS FOR THE CHALLENGE OR EXCLUSION OF ELIGIBLE VOTERS

The following are the only grounds for the challenge or exclusion of eligible voters, to wit: Promotion as permanent Principal on or before the date of the election; retirement; and dismissal from the service without appeal or the dismissal becomes final and executory.

#### V. CHALLENGE VOTERS

All Principals are allowed to cast their votes but their votes shall be segregated.

#### VI. ELECTION PROCEDURE

#### A. POSTING:

- The Management, in coordination with the identified union representatives, shall cause the posting of copies of the duly signed (1) Notice of Certification Election, (2) list of voters, (3) sample ballot and (4) election rules and guidelines.
- The notice of certification election shall be posted at two conspicuous places within the premises of the above-mentioned office at least ten (10) calendar days before the date of the election.

#### B. CASTING OF VOTES

- <u>Preliminary.</u> Before the start of the election or casting of votes on the above described date/s, the Election Officer/Representative from DOLE RO3 and the authorized representatives of the contending organizations shall inspect the polling place and the polling precincts. The ballot box shall be subject to inspection by the parties before the sealing of the same.
- <u>List of voters.</u> The list of employees based on the plantilla submitted by the Management
  as agreed and signed by the parties shall serve as the master list of those who will be
  qualified and allowed to vote in this certification election.

The Management shall provide the list of the rank-and-file teaching personnel sorted alphabetically by Places/Precincts as defined above.

3. Who can vote. Any rank-and-file teaching personnel of DepEd RO3 shall be allowed to vote. Absentee or proxy voting shall NOT be allowed.

- Those who are on preventive suspension or dismissed from service but whose dismissal order is not yet final and executor;
- c. Voters who have not yet exercised their rights but are already within a radius of fifty (50) meters from the polling area before the end of the polling time; and
- d. Principals except that their votes shall be segregated and the determination of which depends if their votes'shall materially affect the results of the certification election.
- 4. <u>Proof of Identification.</u> An employee who desires to vote shall be required to present his/her employee issued Identification Card (ID) or any government issued ID and shall affix his/her signature opposite his/her name in the master list before the issuance of official ballot. No one shall be allowed to vote without exhibiting any of the said IDs.
- Election watchers/representatives. Each contending union shall be entitled to two election watchers - one regular and one alternate. However, contending organizations shall only be allowed one (1) watcher each at a time inside the polling precinct.


All parties shall submit the list of their poll watchers and <u>representatives</u> on 27 August 2019, 9:30 in the morning, at DOLE RO3, CSF, Pampanga. Election watchers shall only be in the list of eligible voters or teaching personnel of DepEd Region 3.

If a ballot is torn, defaced or marked in such a manner that the voter could be identified, or the voter inadvertently spoils or makes an erasure on the ballot he/she shall return such ballot to the Election Officer who in turn, shall destroy the same and replace it with another. Only once, such ballot shall be returned and replaced by another.

### 7. Procedure:

a. Unchallenged voter. If the election officer is satisfied with the identity and qualifications of the voter, a folded official ballot shall be given to the voter.

The voter shall then be required to sign on the blank space opposite his/her name in the official list prepared for this purpose. He shall proceed to a vacant polling booth to cast his/her vote.

After casting, the voter shall fold the ballot and shall personally drop it in the ballot box.

 b. "On-the-spot" challenged voter/s. For voter/voters challenged on the spot, he/she shall sign opposite the blank space provided for his/her signature.

ne voter shall proceed to a vacant polling booth to cast his/her vo



After casting, the voter shall fold the ballot and hand the same to the Election Officer who shall place the same in a white envelope marked 'on-the-spot challenged voter/s" and seal the same in the presence of the parties' respective watchers. The Election Officer shall indicate the voter's name and the ground for challenge. The parties' respective watchers and the Election Officer shall sign the seal of the white envelope.

All "on-the-spot" challenged votes shall be placed in a single brown envelope marked "on-the-spot challenged votes" with the seal duly signed by the watchers of the contending organizations and by the Election Officer.

8. <u>Segregated and challenged votes.</u> These shall be placed in an individual white letter envelope and sealed in the presence of the voter and watchers. The name of the voter, original place of assignment, position and ground/reason for challenge/segregation shall be indicated in the letter envelope. The Election Officer and watchers shall sign the sealed envelope.

All challenged/segregated votes (See IV) shall only be opened and counted after the eligibility of the challenged voter/s shall have been <u>verified/validated</u> by the parties and after all the unchallenged votes shall have been counted.

Where the eligibility of the challenged/segregated votes could not be verified/validated after all the unchallenged votes have been counted, the envelopes of the challenged/segregated voters shall be opened and resolved by the BLR Director provided the number of segregated voters will materially after the results of the election.

#### C. COUNTING AND TALLYING OF VOTES

- Immediately after the close of polling at the precinct level or when the last voter has cast its vote, or when the parties as reflected in the Minutes agree to close the casting of votes before the closing period, votes cast shall be counted and tabulated by the assigned DOLE Board of Election Inspector (BEI) in the precinct.
- The Chairman of the BE's shall read aloud the vote contained in the ballots, tally the
  votes and put a line across the read and tallied ballot, while a member shall tally on
  the Board.
- 3. All votes cast shall be counted and tabulated by the BEI in the presence of the representatives of the union.
- Only one watcher per union is authorized within a three-meter radius from the tallying area. Persons other than those authorized in the preceding paragraph are not allowed to stay within the said three-meter radius.
- 5. In the appreciation of ballots, the Election Officer shall see to it that the voter marks a check (√) inside the square opposite his/her choice. The following votes shall be considered spoiled or invalid:
  - a. A cross (x) inside the square;
  - b. No check (√) inside the square;
  - c. A cross (x), a check (√) or other marking is placed outside the square:
  - d. Double or more markings inside and/or outside the square [e.g. two (2) checks, two (2) crosses or a combination of cross (x) and check ( $\sqrt{1}$ ), etc.];
  - e. The word "yes", "no", "check", or "cross";
  - f. Erasures or use of snow fake; and,

g. Placing of markings other than a check (√).

# D. CANVASSING AND CONSOLIDATION OF ELECTION RESULTS

- Immediately after the close of polling at the precinct level in the branches, votes cast shall be counted and canvassed by the Election Officer at the precinct in the presence of the representatives of the parties.
- After reading and counting the ballot, the BEI shall put a line across the same to indicate that the same has been read and counted.
- 3. Upon completion of the canvassing of votes, the Election Officer shall allow each representative to take a picture of the minutes of the election and the tally sheet.
- 4. Election results, cast ballots, tally sheets, segregated/challenged votes and minutes of the election shall be sealed in an envelope signed by the parties and be forwarded to DOLE RO3 MALSU Office not later than three (3) days from the date of the conduct of election. The province and the school precinct should be clearly identified outside of every sealed envelope. One photocopy of the minutes of the election reflecting the results shall be pasted/taped outside the envelope.
- Upon completion of the counting and canvassing of votes, the Election Officer shall defer the consolidation of votes to the scheduled date and time agreed by the parties;
- 6. During the consolidation votes, each representative shall be furnished a copy of the minutes of the proceeding, and shall endorse the records and election results to the BLR Director for the proclamation of the winner and certification of the sole and exclusive negotiating agent of the rank-and-file teaching personnel of DepEd, if no election protest has been filed during the election.

### E. ELECTION PROTESTS

- All protest/objections relative to the conduct of the certification election shall be formalized before the BLR within five (5) calendar days from the close of the election proceedings or on 13 November 2019. All protests/objections shall be contained/reflected in the minutes of every election results.
- No protest shall be entertained when not contained/reflected in the minutes of the election and/or after the lapse of the five-day reglementary period.
- The winning union shall be proclaimed by the BLR Director five (5) days after the final
  consolidation of votes, provided, however, that no formal protest which would affect the
  result of the election has been filed within the reglementary period.

# VII. MISCELLANEOUS PROVISION

- A. Campaign period. Campaign period shall start on 14 August 2019 and shall end on 12 September 2019. However, campaign on official time shall be recognized subject to the proper coordination with the Management.
- B. Management's duties.
  - Management shall observe strict neutrality during the conduct of the certification election.
  - All officers and authorized representatives of the contending parties, teachers and principals who shall cast their votes shall be on official time during the election days (Thursdays and Fridays) until their completion.

3. Both parties shall submit to the Election Officer a list of officers and authorized representatives. The Management shall issue the appropriate Executive/Office Order.

- C. COMMON POSTER AREA. There shall be a common posting area to be determined by the respective Principals of each schools for the posting of campaigned materials. As to the length and size of posters/campaign materials, the Election Code of the Philippines shall apply.
- D. Voters' decorum. Wearing of T-shirts printed with the name, logo, or campaign line of the contending unions shall NOT be allowed on Election Days. Any other similar propaganda materials that will identify the contending associations shall be strictly prohibited. This prohibition applies as well to the poll watchers of the unions. There shall be no more campaign materials/posters at the polling precincts during the respective dates of the election. Any violation thereof shall be a ground for protest (See VI E.).
- E. On the spot questions, complaints or issues. The designated Election Officer shall immediately resolve legitimate on-the-spot questions, complaints or issues that may be raised by any party concerned which pertained to the conduct of the certification election.
- F. Applicable laws, rules and regulations. The above Guidelines shall govern the conduct of the certification election. The provisions of Executive Order No. 180, its Implementing Rules and Regulations and the Labor Code of the Philippines shall apply suppletorily.
