ISSUANCE OF PERFORMANCE RATING CERTIFICATION FOR MID-YEAR BONUS

To:

Elementary and Secondary School Heads Teaching and Non-Teaching Personnel Division Personnel

Relative to DBM Budget Circular No. 2. S. 2017, "Rules and Regulations on the Grant of the Mid-Year Bonus for FY 2017 and Years Thereafter", the Mid-Year Bonus equivalent to one (1) month basic pay as of May 15 shall be given to entitled personnel not earlier than May 15 of the current year. One of the conditions stated is that, to be eligible, the personnel must have obtained at least a satisfactory performance rating in the immediately preceding rating period, or the applicable performance appraisal period.
