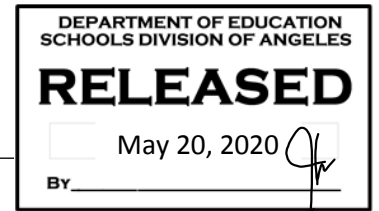

**SUBMISSION OF PRIVATE SCHOOLS' LEARNING CONTINUITY PLAN
AND OTHER DOCUMENTS IN RELATION TO OPENING OF CLASSES**

To: Private School Administrators

1. As stipulated in DepEd Order No. 007, s. 2020 entitled "School Calendar and Activities for School Year 2020-2021" and Regional Memorandum No. 117, S.2020 entitled "Submission of Private School's Learning Continuity Plan and other Documents in Relation to Opening of Classes", private schools offering basic education will be allowed to open classes within the period authorized by RA 7797 which is on the first Monday of June but not later than the last day of August, provided:

- a. No face-to-face classes will be allowed earlier than August 24, 2020, and from then on, face-to-face classes may be conducted only in areas allowed to open physically.
- b. They submit in advance the following documents to the DepEd Regional Offices (ROs) for review and monitoring purposes:
 - i. Their school's plan for compliance with minimum health standards that will be issued by DepEd, consistent with guidelines of the DOH, the IATF and the OP;
 - ii. Their school's Learning Continuity Plan showing alternative delivery modes of learning when face-to-face learning is not allowed, which shall constitute compliance with the requirement provided under Item 6 of Annex 3, DepEd Order No. 021, s.2019 and;
 - iii. Their school's SY 2020-2021 School Calendar.

2. In line with this, all private schools are advised to submit the above mentioned documents to the Division Office via angeles.city@deped.gov.ph and edna.canlas001@deped.gov.ph.

3. The deadline of submission of the required documents to the Division Office for processing and evaluation is as follows:

- a. May 21, 2020 – For those schools which will open on June 1 or June 8, 2020;
- b. May 25, 2020 – For those schools which will open on June 15 or June 20, 2020;
- c. June 1, 2020 – For those schools which will open on June 29, 2020;
- d. June 8, 2020 – For those schools which will open in July 2020; and
- e. June 29, 2020 – For those schools which will open in August 2020.
