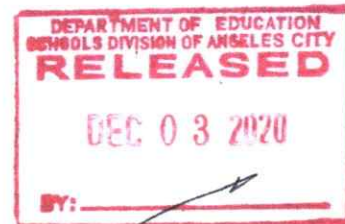



BASIC TRAINING COURSE FOR TROOP LEADERS

To: Heads of Public and Private Elementary Schools

1. The BSP Angeles City Council will conduct Basic Training Courses for Troop Leaders on December 11-13, 2020 via Zoom Apps with the theme: "Commitment to Excellent."
2. The aims of the Basic Training Course are as follows:
 - a. Help the participants understand the historical background, fundamental principle, organization structure, and spirit of Scouting;
 - b. Assist the participants understand the needs of young people within the specific environment in which the leaders and young people will be working;
 - c. Equip the participants with the ability to use the Scout Methods and the skills of Scouting to meet the needs and aspiration of young people adapted for Boy Scouting Section;
 - d. Help the participants appreciate the application of the team systems and enabling youth involvement and youth empowerment through learning by doing, and symbolic framework;
 - e. Train the participants personal on leaderships skills to work positively and constructively with young people and other adults; and
 - f. Arm the participants with management skills to plan for, implement, administer, and evaluate the Sectional Youth Program that will contribute to the personal growth of young people to play a constructive role in the society.
3. Participants are the Grades 4-6 teachers who registered unit leaders, assistant unit leaders, or scouting coordinators with official neckerchiefs and slides.
4. No registration fee shall be charged on this training.
