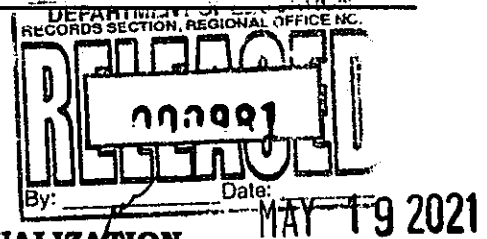

To: Schools Division Superintendents

1. This Office, through the Human Resource Development Division-National Educators Academy of the Philippines, Region III (HRDD-NEAP-R3), will conduct a *Seminar-Workshop on Research Conceptualization, Preparation, and Publication* on June 1, 2, and 30, 2021 via MS Teams platform.

2. The aforementioned capacity-building activity is anchored on the results of the Training Needs Assessment (TNA) on Research Competency which was administered on March 8, 2021. Findings show that there is a significant need to conduct series of trainings on research in line with the global trends.

3. In compliance with the DepEd Order No. 001, s. 2020 stipulating the Guidelines on the NEAP Recognition of Professional Development Programs/Courses for Teachers and School Leaders, the HRDD-NEAP-R3 submitted this Professional Development program to the NEAPCO for evaluation and recognition.

4. Guided by the minimum requirements provided by DO No. 082, s. 2020 entitled Guidelines on Registration of Teachers and School Leaders, participants in the three-day activity shall include two (2) Education Program Supervisors, two (2) Public Schools District Supervisors, and six (6) Master Teachers from each Schools Division Office. Specifically, the selection criteria for the target participants are the following:

- Permanent or regular employees (with plantilla positions) of the Department of Education Region III;
- Have a Research Proposal approved by the SDO;
- No pending administrative, civil, or criminal case as a defendant, respondent, or accused as the case may be;
- Not been found guilty of any violation involving corruption, fraud, or moral turpitude;
- With a performance rating of at least "Very Satisfactory" in the last rating period.
- Not be retiring from public service in less than a year;


