ADDENDUM TO THE DIVISION MEMORANDUM NO. 195, S. 2021
"ADMINISTRATION OF 2021 COMPUTER-BASED ENGLISH PROFICIENCY TEST (CB EPT) FOR TEACHER-APPLICANTS"

- 1. In line with the declaration of COVID-19 Delta Variant cases in the Philippines based on the latest genome sequencing report by the DOH and UP-PGC, this Division deemed it necessary to enforce strict health protocols and measures to ensure the safety of all who will be participating in the said examination. Similarly, the following shall also be strictly observed:
 - Teacher-examinees who are not yet vaccinated, those who received at least one (1) vaccine dose, and those who are fully vaccinated for more than 2 weeks from the date of examination will be required to undergo Rapid Antigen Test. Thus, they are requested to present the results of their Antigen Test administered and released in the last 72 hours during the examination day;
 - Teacher-examinees who are fully vaccinated within two (2) weeks prior to the date of examination will no longer be subjected to the Rapid Antigen Test, however, they are requested to bring their Vaccination Cards with latest pictures and Medical Certificates issued either by the City or Barangay Health Office; and
 - All testing personnel are advised to have their Rapid Antigen Test on August 2, 2021
 (9:00 AM) at the School Health and Nutrition Unit. Likewise, testing personnel on a
 "work from home" schedule are also advised to have their Rapid Antigen Test on the
 said date.
