- 4. Output must be submitted 3 MINUTES after the competition via ginnojhep.pacquing@deped.gov.ph or upload in the google drive provided during the competition.
- 5. File name format should follow POSTER DIVISION. (POSTER AURORA)
- 6. Student-participant may be accompanied by one coach. However, coaches are only allowed to assist the student during the setting up of materials on the day of the competition
- 7. Participants shall provide ½ size illustration board and must use the white background in vertical background.
- 8. The medium for visual artistry shall only be limited to oil pastel and shall be provided by the contestant.
- 9. Participants are not allowed to bring pictures or images for reference of their

- 6. Videos should be encoded on commonly known video file compressions/formats such as .mp4, .avi, and .mkv.
- 7. Entries must be submitted to ginnojhep.pacquing@deped.gov.ph on or before 12:00 NN of December 06, 2021, using the Coach's official DepEd email address.
- 8. A Google Drive link may also be used to submit large file formats. In the event that the link is broken/defective or not accessible, the submitted entry will no
