- 1. One of the good governance conditions that need to be complied with is the submission and filing of the Swom Statement of Assets, Liabilities and Net Worth (SALN) of Officials and Employees which is in accordance with RA 6713, otherwise known as Code of Conduct and Ethical Standards for Public Officials and Employees, which states that SALN must be filed:
 - a. within thirty (30) days after assumption of the office;
 - b. on or before April 30 of every year thereafter; and
 - c. within thirty (30) days after separation from the service.
- 2. Failure to comply of an official to submit his/her SALN in accordance with the procedure and within the given period shall be a ground for disciplinary action. The offense of failure to file SALN is punishable with the following penalties:
 - a. 1st offense- suspension for one (1) month and one (1) day to six (6) months
 - b. 2nd offense- dismissal from the service
