## CONDUCT OF THE 2022 2ND QUARTER NATIONWIDE SIMULTANEOUS EARTHQUAKE DRILL (NSED)

1. Pursuant to OUA Memorandum No 00-0522-0165 and the approved NDRRMC Memorandum No. 21, s. 2022, titled "Conduct of the CY 2022 Quarterly Nationwide Simultaneous Earthquake Drill", the Schools Division of Angeles City, through the Division DRRM Coordinator enjoins all schools to participate in the conduct of the 2nd Quarter Nationwide Simultaneous Earthquake Drill (NSED) on June 9, 2022 (Thursday) at 9:00 a.m.

2. In adherence to health protocols, NSED exercises requiring physical interaction, particularly evacuation drills in DepEd offices and schools, are suspended. However, all personnel and learners of the Division are enjoined to practice "duck, cover, and hold" procedure at the set time in their workplace or home.

3. The School DRRM Coordinators shall accomplish the School Reporting Template in Google Form through this link https://bit.ly/LuzonSchools2Q on or before June 15, 2022.

#### Subject: **REITERATION OF PARTICIPATION TO THE 2022 2nd QUARTER** NATIONWIDE SIMULTANEOUS EARTHQUAKE DRILL (NSED) ACTIVITIES

In relation to the approved National Disaster Risk Reduction and Management Council (NDRRMC) Memorandum No. 21, s. 2022 titled 'Conduct of the CY 2022 Quarterly Nationwide Simultaneous Earthquake Drill,' the Office of the Undersecretary for Administration (OUA), through the Disaster Risk Reduction and Management Service (DRRMS), enjoins schools and offices across all levels of the Department of Education (DepEd) to participate in the 2022 2nd Quarter Nationwide Simultaneous Earthquake Drill (NSED) on Thursday, June 09, 2022, 9:00 AM.

Due to the limitations in the conduct of mass gatherings and adherence to minimum public health standards, NSED exercises requiring physical interaction, particularly evacuation drills in DepEd offices and schools, are hereby suspended. However, all DepEd personnel and learners are enjoined to practice the "duck, cover, and hold" procedure simultaneously at the set time.

In order to further raise awareness regarding the earthquake drill, DRRM coordinators are encouraged to:

1. intensify the Information, Education, and Communication (IEC) campaign by displaying earthquake preparedness measures at the offices and school bulletins or through online forums such as social media platforms and video conferences:

- 3. distribute maps containing evacuation routes and sites (at school or community) in coordination with LDRRMOs/BDRRMCs.

#### Annex A

#### Guidelines on the Submission of the 2022 2nd Quarter Nationwide Simultaneous Earthquake Drill (NSED) Reports

All schools, schools division offices, and regional offices should thoroughly follow the guidelines below. Non-compliance is tantamount to the non-acceptance of said reports.

### 2nd Quarter NSED Google Forms:

- 1. The School DRRM Coordinators shall fill out a google form link which is clustered into three (3), namely for schools in:
  - a. Luzon <u>https://bit.ly/LuzonSchools2Q</u>
  - b. Visayas https://bit.ly/VisayasSchools2Q
  - c. Mindanao https://bit.ly/MindanaoSchools2Q
- The Region and Division DRRM Coordinators shall also fill out a google form link specific for their respective offices:
  - a. Division <u>https://bit.ly/Division20</u>
  - b. Region https://bit.ly/Region2Q
- 3. The School, Division, and Region DRRM Coordinators shall accomplish the google form **not later than five (5) working days after quarterly NSED**.
- 4. In case schools are not able to access or fill out the Google Form due to internet connectivity issues, they may opt to use the attached reporting template (Annex B. School Reporting Template) and submit a copy through email to the respective Division DRRM Coordinator not later than ten (10) working days after the quarterly NSED.

#### **Consolidation of Reports**

- 1. The DRRMS will provide the regions and divisions daily updates of the NSED report submission after quarterly NSED.
- The DRRMS will provide the regions and divisions the final consolidated report ten (10) working days after quarterly NSED and shall be vetted by the Division DRRM coordinators.
- 3. The Division DRRM coordinators shall vet the final consolidated report. Should they find schools not included, kindly add and have the file be signed by the Schools Division Superintendent (SDS), and submit to respective Regional DRRM Coordinators copy furnish respective SDS not later than **thirteen (13) working days after quarterly NSED**.
- 4. The Regional DRRM coordinators must consolidate NSED reports from Division DRRM coordinators and send to the DRRMS via email drrmo+dp@deped.gov.ph copy furnish respective Regional Directors not later than **sixteen (16) working days, after quarterly NSED**.
- 5. The official number of schools that participated in NSED will be based on the final consolidated NSED report signed by the Regional Director or authorized official from the regional office to be submitted to DRRMS.
