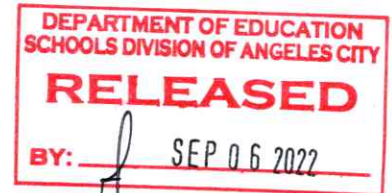

1. Please be informed that the Administration of Computer-Based English Proficiency Test (CB-EPT) for the 2nd Wave of Application for Teacher Applicants is scheduled on September 7, 2022 (Wednesday) from 1:00 p.m. to 5:00 p.m. at DepEd Angeles City Library Hub, Pulungbulu, Angeles City.
2. Relative to this, an orientation of all the testing personnel and teacher-examinees on the Conduct of the CB-EPT will be held from 10:00 a.m. to 12:00 n.n. on the same day and place of the test.
3. All teacher-examinees and testing personnel are required to follow the minimum safety, health standards and protocols throughout the testing day and shall register in the contact tracing app of DepEd Angeles City through <https://bit.ly/StaySafeAC> at least 1 hour before the test.
