2022 ANGELES CITY AMATEUR ATHLETICS ASSOCIATION (ACAAA) VIRTUAL SPORTS SKILLS DEMONSTRATION CONTEST

TO: Heads of Public and Private Elementary and Secondary Schools

- 1. Pursuant to OASGFO No. 2022-058 "Request for the Participation of Learners and Teachers in Extra-curricular Activities" and RM No. 621, s. 2022 "Co-curricular Activities that are Allowed to be Conducted Starting School Year 2022-2023," please be informed that the Schools Division of Angeles City will conduct the "2022 Angeles City Amateur Athletics Association (ACAAA) Virtual Sports Skills Demonstration Contest" on December 3, 2022.
- 2. The activity aims to:
 - a. provide an alternative venue for public and private school student-athletes to demonstrate their athletic abilities; and
 - b. provide financial support to public and private schools, especially school sports organizations and sports activities, by giving monetary awards to the winners.
- 3. All participating teams shall strictly observe the minimum safety protocols during the preparation and participation in the 2022 ACAAA Virtual Sports Skills Demonstration Contest.
- 4. Submission of documents of athletes and coaches will be on November 21, 2022, while the submission of the video entries shall be on November 24, 2022.
- 5. All expenses related to the conduct of the said activity shall be charged to the 2022 SEF Annual Budget under Sports Development Programs subject to usual accounting and auditing rules and regulations.
- 6. Enclosed are the General Information and Mechanics on the conduct of 2021 ACAAA Sports Skills Exhibition Contest, List of Sports Events with number of Participants, and calendar of activities.
- 7. Wide dissemination of and strict compliance to the contents of this Memorandum is highly enjoined.

General Information and Mechanics on the Conduct of 2022 ACAAA Sports Skills Demonstration Contest

- 1. The contest shall be open to student athletes from both elementary and secondary schools currently enrolled in school year (SY) 2022-2023.
- 2. The 2022 ACAAA Sports Skills Demonstration Contest shall be managed by the Education Program Supervisor with the Tournament Managers and Technical Working Groups under the supervision of the Chief Education Supervisor of the School Governance and Operations Division.
- 3. The Sports Skills Demonstration Contest shall be performed virtually via a recorded performance.
- 4. Participating groups shall submit a recorded entry of their performance in accordance with the standards for entry submission.
- 5. The Tournament Managers of the different sports events of public schools and private elementary and secondary schools shall oversee the identification and selection of student-athletes who will participate in the sports skills demonstration contest.
- 6. The different clusters of public schools and representatives from the private elementary and secondary schools shall be allowed to choose the event/s that they want to participate in.
- 7. The decision of the judges shall be final; protests shall not be entertained.
- 8. Cash awards and participation allowance shall be awarded to the winners of the different events.

Entries

- 1. Entries containing the performances of teams shall be recorded after class hours.
- 2. Performances shall be done within a 3 5 minute time limit.
- 3. Performances shall be accompanied by any genre of music or any musical instrument of choice as background. The use of vocal music with vulgar words is strictly prohibited.
- 4. The use of stage props or any paraphernalia and/or apparatus shall be allowed provided it will not cause any harm or post any risk for accident during the performance.
- 5. Stunts and other forms of acrobatics such as pyramids, lifts, throws, among others that may cause any harm or accident during the performance are highly discouraged.
- 6. The entry video will be in landscape frame, with one (1) stationary camera set up (no zooming, no video mixing, must be fixed).
- 7. Participants need to observe the space while they are moving that requires not being out of the frame.
- 8. Participant must wear their respective school PE Uniform or any appropriate /comfortable attire such as jogging pants, t-shirts, and rubber shoes.

Venue

- The competing teams shall use the school gym/stage or any venue or hall that has enough room, is clear of protruding items, and poses no hazard as site for training, rehearsals, and real filming or recording of entry.
- The floor surface shall be flat and free from projecting items and covered with any material that is safe for the athletes to move on, such as puzzle mats or wrestling mats, if available.

Judging

- 1. All entries shall be evaluated using a scoring system to be developed by the Organizing/Technical Working Committee.
- 2. Contest mechanics and criteria for judging for each sports event shall be given by Tournament Managers to interested parties.
- 3. Each judge shall independently record his/her score on every performance. Judges' score shall then be forwarded to the Head of the Board of Judges for his/her validation of the final score earned.
- 4. The team that earned the highest score shall be declared the champion.
- 5. Should there be a tie in the scores, the board of judges shall convene in a separate conference room to review the entries if necessary, and discuss, deliberate, and come up with a collegial decision and determine the winner.
