

1. The Enhanced Basic Education Program, as stipulated in Republic Act No. 10533 and the Indigenous Peoples Education (IPED) provision of its Implementing Rules and Regulations (Sec. 8.4), mandates DepEd to develop a curriculum that is culture-sensitive, contextualized, and flexible enough to enable and allow schools to localize and indigenize based on the social context of Indigenous Cultural Communities (ICCs). In support of this mandate, DepEd Region III, through the Curriculum and Learning Management Division (CLMD), shall conduct the **Quality Assurance of Grade 5 Araling Panlipunan (AP) Storybooks on Indigenous Peoples' Cultural Standards cum Regional Meeting of Division IPED Focal Persons on December 20-21, 2022**, at a venue to be announced later.
2. In this workshop, the participants are expected to develop a holistic perspective on the overall learning and socio-cultural context of ICCs. In particular, participating divisions are expected to quality assure with elders/culture-bearers the storybooks based on the cultural standards of the nine indigenous peoples' (IPs) ethnolinguistic groups. These stories of ICCs will be developed as learning resource materials to be utilized in teaching Grade 5 AP. Stories will be written in nine indigenous peoples' (IPs) languages with Filipino translations.
3. Participants in this activity are the Division IPED program focal persons, Division IPED program alternate focal persons, school heads (writers), IP culture-bearers, and illustrators from each division who have IPED trainings and orientation or have been immersed in ICCs and gained IP perspective. Each IPED implementing

division is required to submit at least one quality-assured storybook on IP cultural standards after the training to the google link which will be provided.

4. Participants in this writeshop are expected to bring their own laptops and extension cords.
5. Participants are expected to be at the venue at exactly 8:00 a.m. on December 20, 2022, and leave the venue at 5:00 p.m. on December 21, 2022, exclusive of travel time.
6. Communication expenses/travel expenses and all other incidental expenses of all division participants including the honoraria of IP elders/culture-bearers shall be charged to Division IPED Program Support Funds or other local sources of funds subject to the usual accounting and auditing rules and regulations.
