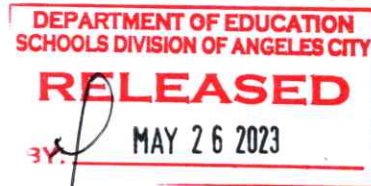

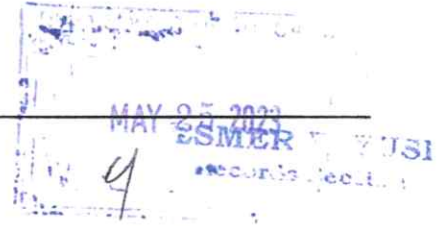



Dear **Director Eclar**:

We hope that you are doing well.

We are writing to respectfully request assistance in disseminating information regarding issuance and release of Certificates of Registration (COR) to your personnel who are registered professionals.

To date, PRC Regional Office III has a total of 7,263 unclaimed CORs of Licensed Professional Teachers. PRC CORs, otherwise known as Board Certificate/'Lupon', is the material proof of eligibility, while the Professional Identification Card (PIC) serves as identification as a licensed professional.

A COR is issued six (6) months upon Initial Registration to licensed professionals (Initial Registration is the process upon which the first-ever PRC ID of the person is issued after successfully passing the licensure examination).

In order to facilitate the prompt release of the unclaimed CORs, we would like to respectfully request that the following information be cascaded to the Schools Division Offices and DepEd schools within the region:

Issuance of PRC Certificate of Registration to LEPT Passers from 2018-2023	
Who are eligible	Licensed Professional Teachers who undertook their Initial Registration (or first time issuance of a PRC ID) from 2018-2022 at any of the following PRC Region III Offices: <ul style="list-style-type: none">• Pampanga Capitol Compound;• Robinsons Starmills;• My Metro Town Tarlac City;• OSCCO Palayan Nueva Ecija; or• during any of our mobile services in the region
Where to claim	PRC Pampanga Capitol Compound, City of San Fernando, Pampanga
When to claim	Mondays thru Fridays, 8am-5pm
What to bring	PRC ID and one (1) documentary stamp
How to verify availability	To check COR availability at PRC Capitol Compound, kindly call 0956-830-5757, or email ro3@prc.gov.ph before visit
