




Dear Secretary Angara:

Greetings from the Boy Scouts of the Philippines!

In accordance with Article V, Section 1 of the National By-laws of the Boy Scouts of the Philippines, 'The National Council shall hold an annual meeting not later than May 31 of each year, at such time, date and place may be determined by the National Executive Board for the purpose of receiving the annual reports of the officers, electing the regular members of the National Executive Board, ratifying any proposed amendment to these By-laws and transacting such other business as may properly come before the meeting.'

Relative to the above stated provisions, the Boy Scouts of the Philippines will hold the 68th Annual National Council Meeting on 26-28 February 2025 at Legazpi City Convention Center, Legazpi City hosted by the BSP Mayon and Legazpi City Councils.
