

- to serve as DepEd's institutional link to volunteer organizations and individuals;
- to provide close horizontal and vertical coordination and consultation among DepEd, COMELEC, and partner agencies involved in the 2025 National and Local Elections; and
- to complement the other government agencies' efforts for an honest, orderly, and peaceful elections.
- 5. Likewise, the following are the schedules of SDO Election Task Force to ensure effective and efficient delivery of services during, before, and after the May **2025 National and Local Elections**:
 - Set-up and preparations May 9, 2025
 - Start of Monitoring and Operations May 12, 2025
 - Election Day May 12, 2025
 - End of Monitoring and Operations May 13, 2025
