21st National Oral Health Month Celebration

1. Presidential Proclamation No. 559, series of 2004, declares the month of February every year as National Dental Health Month. This celebration aims to promote oral health awareness and education nationwide and emphasize the inclusivity and protection of the rights of children with disabilities to access quality oral health care.

THIRD WEEK (Feb. 17-21, 2025)	Delivery of Dental Services: <ul style="list-style-type: none">Collaborate with local dental clinics or practitioners to organize on-site dental check-ups for learners.Free dental check-ups and consultations at school clinics.
FOURTH WEEK (Feb. 24-28, 2025)	Interactive Workshops: <ul style="list-style-type: none">Set up interactive workshops that include hands-on activities.Have demonstrations on proper brushing techniques and provide learners with toothbrushes and toothpaste.

4. All public elementary and secondary schools are required to submit narrative reports with MOVs to the Division Office Dentist-In-Charge after the celebration not later than March 5, 2025 or may email: ramil.policarpio@deped.gov.ph
