- 1. In line with the Quality Management System (QMS) implementation of the Department of Education (DepEd) in standardizing various processes across all governance levels, this Office hereby issues the Updated Timeline for the submission of private school applications relative to their operation.
- 2. This issuance aims to establish a **standard timeline** for the submission of private school applications to **ensure compliance** with DepEd's set standards and regulations.
- 3. All Schools Division Offices and private schools must strictly adhere to the prescribed timeline. Applications submitted **beyond the deadline** will not be processed or acted upon. For reference, the **Updated Timeline** for private school application submissions is attached to this memorandum.
