Submission of Activity Requests Aligned with Approved PPAs in the Annual Implementation Plan-Work Financial Plan for FY 2025, and Request for Authority to Conduct

- 1. In line with our commitment to ensuring the efficient implementation of our programs, projects, and activities (PPAs) as outlined in the approved Annual Implementation Plan (AIP)-Work Financial Plan (WFP) for the fiscal year 2025, this office is requiring all school principals to submit their respective **activity requests**.
- 2. Please ensure that your submissions are aligned with the approved PPAs and adhere to the following guidelines:
 - 1. **Submission Deadline:** All activity requests must be submitted until **March 14, 2025.**
 - 2. **Format:** Use the standardized Activity Request Form provided by the administration. Ensure all sections are completed accurately.
 - 3. **Justification:** Provide a clear and concise justification for each activity, highlighting its relevance to the approved PPAs.
 - 4. **Budget Estimates:** Include detailed budget estimates for each activity, ensuring they are within the allocated budget in the WFP.
 - 5. **Supporting Documents:** Attach any necessary supporting documents, such as proposals.
- 3. To request for **Authority to Conduct** for Programs, Projects, and Activities (PPAs) not included in the Annual Implementation Plan (AIP)-Work Financial Plan (WFP), follow these steps:
 - 1. **Identify the Need:** Clearly define the necessity and objectives of the PPA. Ensure it aligns with the overall goals and priorities of the school.
 - 2. **Prepare a Proposal:** Draft a detailed proposal outlining the PPA, including its objectives, expected outcomes, timeline, and budget. Highlight why it was not included in the original AIP and WFP.
 - 3. **Seek Approval:** Submit the proposal to the Schools Division Office of Angeles City, for review and approval of the SDS.
 - 4. **Realignment of Funds:** If approved, coordinate with the finance unit to realign funds from other budgeted activities or identify alternative funding sources. This may require completing an ATC Form.

- 4. Under General Appropriation Act, FY 2025, any available allotment from the amounts programmed for **petroleum**, **oil and lubricants**, **water**, illumination and **electric or power services**, **telephone and other communication services including internet** may be modified only in the **last quarter** of the fiscal year and subject to the provisions of Section 80 hereof.
- 5. Prompt and wide dissemination of, and adherence to, this memorandum are hereby mandated.
