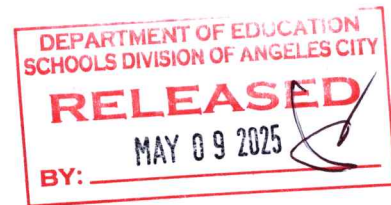

1. Relative to Division Memorandum No. 128, s. 2025: Conduct of Division Checking of School Forms, please be informed that the continuation of the validation process for Lower Grades has been rescheduled to May 20, 21, & 23, 2025.
2. It is reiterated that **teachers must not be required to report to school during this period, as it falls within their uninterrupted vacation.** Furthermore, all school forms should have been submitted to the Office of the School Principal by April 15, 2025 (End of the School Year). Only the school principal and other non-teaching personnel are involved in the activity.
3. Enclosure 1 is attached, providing updated details on the venue, schedules of schools, and assigned DCC team members. The Chief Education Supervisors and Legal Officer will monitor the activity.
4. All other contents of the Memorandum remain the same.
