Subject: Annual Physical Examination of Teaching and Non-Teaching Personnel for SY 2025–2026

To: SGOD and CID Chiefs

Public Elementary and Secondary School Heads

All Others Concerned

- 1. In line with CSC Memorandum Circular No. 17, s. 1989 on maintaining physical and mental fitness for public service, and Regional Memorandum No. 76, s. 2005 on the Health Welfare Enhancement Program, all teaching and non-teaching personnel are required to undergo the Annual Physical Examination (APE) for School Year 2025–2026.
- 2. This initiative aims to ensure that all employees are physically fit to perform their duties effectively. Please note that the following diagnostic tests are required, except for pregnant women in their first and second trimesters, who are advised to undergo **Sputum Microscopy** instead:

FASTING: Last meal should be 10 - 12 hours before the procedure.

- a. Chest X-ray except for pregnant women during 1st and 2nd trimester
- b. Fasting Blood Sugar
- c. Total Cholesterol/HDL/LDL
- d. Blood Urea Nitrogen
- e. Blood Uric Acid
- f. Creatinine
- g. Triglyceride
- h. SGPT/SGOT
- I. Complete Blood Count
- j. Urinalysis
- k. ECG
- 3. Employees may avail of the required laboratory tests and medical consultations **free of charge** through **PhilHealth's E-Konsulta Program** at any of the accredited clinics listed below:
 - **PSNalo Family Health Care Clinic** (with NFHC Precision Medhub) 774 Sto. Rosario St., Manuela Arcade, Angeles City (same building as Pandayan Bookstore)
