- 1. This is to announce the submission of SARP Student Assessment Record and Recomputed Final Grades (RFGs) of all learners who attended the 2025 Summer Academic Remedial Program (SARP). The deadline is on June 9, 2025.
- 2. These records will serve as the basis for the Division's evaluation and approval of learners' eligibility for promotion, as well as other provisions outlined in DepEd Order No. 8, s. 2015.

3. The following records are required for submission:

- 4. The SARP Student Assessment Record must be completed per subject area. The required data include:
 - Baseline Assessment final grade from the previous school year
 - Midline Assessment grade as of May 28, 2025
 - Endline Assessment grade as of June 9, 2025

The record must be signed by both the subject teacher and the school head. Once signed, it must be uploaded to the designated folder corresponding to the school name via the link provided above. This submission is monitored by the Central Office.

5. The Certificate of Recomputed Final Grade template reflects the average of the Baseline and Endline Assessments, as recorded in the SARP Student Assessment
