Description

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Education– Schools Division of Angeles City now invites bids for CY 2022 BASIC EDUCATIONAL FACILITIES FUNDS- REPAIR OF CLASSROOMS. Completion of the Works is indicated at the table above. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II: Instruction to Bidders.

3. Bidding will be conducted through an open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Department of Education – Schools Division of Angeles City and inspect the Bidding Documents at the address given below every Monday-Friday at 8:00 a.m. to 5:00 p.m.

5. A complete set of Bidding Documents may be acquired by interested bidders every Monday-Friday from June 24- July 13, 2022, 8:00a.m.-5:00p.m. at Jesus Street, Pulungbulo, Angeles City, and upon payment of the non-refundable fee, pursuant to the latest Guidelines issued by the GPPB as stated below:

Interested bidders are required by the Division BAC to present their original PCAB license, and a Special Power of Attorney (SPA) if the buyer is a representative of the owner of the company. Bidders are also required to submit their Gmail address/account, upon buying of Bidding Documents, where the BAC Secretariat will send a link for the opening of bids.

Health protocols (e.g. wearing of face mask and face shield) observed in the division office must be strictly followed before entering the premises. Swab Test, Medical Certificate and Quarantine Pass are required to bidders outside Pampanga. Bidders/representatives must bring their own pen.

6. The Department of Education- Schools Division of Angeles City will hold a Virtual Pre-Bid Conference on July 1, 2022 10:00 a.m. through Microsoft Teams.

7. Bid proposals must be duly received by the BAC Secretariat who choose to attend via virtual platform on or before July 13, 2022 at 9:30 a.m.. Late bids shall not be accepted. All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 18.

The opening of bids will be online using Google Meet Platform on July 13, 2022, 10:00 a.m. Bids will be opened in the virtual presence of the bidders' representatives who choose to join in the online bidding.

8. The Department of Education- Schools Division of Angeles City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
