## **Description**

PROCUREMENT OF BONDPAPERS FOR THE PROVISION OF LEARNING RESOURCES FOR KINDER TO GRADE 3 LEARNERS FOR THIRD AND FOURTH QUARTER REQUIREMENTS SY 2020-2021

- 1. The Department of Education- Schools Division of Angeles City, through part of the FY 2021 GAA SUB-ARO Order No. DEPED-ROIII-2021-02-026 dated February 10, 2021 intends to apply the sum of Six Million Fifty One Thousand Four Hundred Twenty Seven Pesos and Twenty Six Centavos (Php 6,051,427.26) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Bond papers for the Provision of Learning Resources for Kinder to Grade 3 Learners for Third and Fourth Quarter Requirements SY 2020-2021. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Education- Schools Division of Angeles City, now invites bids for Procurement of Bond papers Provision of Learning Resources for Kinder to Grade 3 Learners for Third and Fourth Quarter Requirements SY 2020-2021. Delivery of the Goods is required within 30 calendar days after the issuance of Notice to Proceed. Bidders should have completed from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty

percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Department of Education - Schools Division of Angeles City and inspect the Bidding Documents at the address given below during Monday, Tuesday, Wednesday and Friday, 8:00a.m.-5:00p.m. and every Thursday from 8:00am to 3:00pm only from March 24, 2021 - April 13, 2021.

More than 5 Million up to 10 Million 10,000.00

More than 10 Million up to 50 Million 25,000.00

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
