Description

PROCUREMENT OF PRINTERS AND INK FOR THE PROVISION OF LEARNING RESOURCES FOR ARTS, PHYSICAL EDUCATION, ARALING PANLIPUNAN, EDUKASYON SA PAGPAPAKATAO AND MUSIC FOR QUARTER 3 OF SY 2020-2021

- 1. The Department of Education- Schools Division of Angeles City, through part of the FY 2021 GAA SUB-ARO Order No. DEPED-ROIII-2021-03-088 dated March 8, 2021 intends to apply the sum of One Million Nine Hundred Forty Seven Thousand and Two Hundred Fifty Pesos Only (Php 1,947,250.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Printers and Ink for the Provision of Learning Resources for for Arts, Physical Education, Araling Panlipunan, Edukasyon sa Pagpapakatao, and Music for Quarter 3 of SY 2020-2021. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Education- Schools Division of Angeles City, now invites bids for Provision of Learning Resources for for Arts, Physical Education, Araling Panlipunan, Edukasyon sa Pagpapakatao, and Music for Quarter 3 of SY 2020-2021. Delivery of the Goods is required within 30 days after the issuance of Notice to Proceed. Bidders should have completed from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

- (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from Department of Education- Schools Division of Angeles City and inspect the Bidding Documents at the address given below during Monday, Tuesday, Wednesday and Friday, 8:00a.m.-5:00p.m. and every Thursday from 8:00am to 3:00pm only from March 26, 2021 - April 15, 2021.

Interested bidders are advised to strictly observe Health protocols in the division office

- Fill-up the health declaration form provided by guard on duty.
- Have your temperature checked and recorded
- Properly wear your face mask and face shield
- Bidders/representatives must bring their own pen
- 5. A complete set of Bidding Documents may be acquired by interested bidders every Monday, Tuesday, Wednesday and Friday, 8:00a.m.-5:00p.m. and every Thursday from 8:00am to 3:00pm only from March 26, 2021 - April 13, 2021 at Jesus Street, Pulungbulu, Angeles City, and upon payment of the non-refundable fee, pursuant to the latest Guidelines issued by the GPPB as stated below:

- 6. The Department of Education, Schools Division of Angeles will hold a Virtual Pre-Bid Conference on March 31, 2021, 10:00 a.m. through Google Meet Platform.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before April 15, 2021, 8:00-9:30 a.m.. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

The opening of bids will be online using Google Meet Platform on April 13, 2021, 10:00 a.m through Google Meet Platform. Bids will be opened in the virtual presence of the bidders' representatives who choose to join in the online bidding.

The Department of Education- Schools Division of Angeles City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
