Description

Purchase of SPED Equipment and Materials for SPED Inclusive Learning Resource Center (ILRC)

1. The Department of Education- Schools Division of Angeles City, through part of the FY 2021 GAA 3-21-3736 dated August 27, 2021 SUB-ARO Order No. DEPED-ROIII-2021-09-2030 intends to apply the sum of Two Million Pesos only (Php 2,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Purchase of SPED Equipment and Materials for SPED Inclusive Learning Resource Center (ILRC). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Education- Schools Division of Angeles City, now invites bids for Purchase of SPED Equipment and Materials for SPED Inclusive Learning Resource Center (ILRC). Delivery of the Goods is required within 30 days after the issuance of Notice to Proceed. Bidders should have completed, from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

(i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Department of Education– Schools Division of Angeles City and inspect the Bidding Documents at the address given below during Monday-Friday, 8:00a.m.-5:00p.m. from October 27, 2021–November 16, 2021.

Interested bidders are advised to strictly observe Health protocols in the division office;

- Fill-up the health declaration form provided by guard on duty,
- Have your temperature checked and recorded,
- Properly wear your face mask and face shield,
- Bidders/representatives must bring their own pen.

5. A complete set of Bidding Documents may be acquired by interested bidders every Monday-Friday, 8:00a.m-5:00p.m. from from October 27, 2021–November 16, 2021 at Jesus Street, Pulungbulu, Angeles City, and upon payment of the non-refundable fee, pursuant to the latest Guidelines issued by the GPPB as stated below:

500,000 and below 500.00

More than 500,000 up to 1 Million 1,000.00

More than 1 Million up to 5 Million 5,000.00

More than 5 Million up to 10 Million 10,000.00

More than 10 Million up to 50 Million 25,000.00

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Interested bidders are requested to provide their Gmail address/account, upon buying of Bidding Documents. BAC Secretariat will email the conference link for the online pre bid conference as well as the opening of bids using Google Meet platform.

6. The Department of Education, Schools Division of Angeles will hold a Virtual Pre-Bid Conference on November 3, 2021, 10:00a.m. through Google Meet Platform.

7. Bids must be duly received by the BAC Secretariat at the address below on or before November 16, 2021, 8:00-9:30a.m.. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

The opening of bids will be online using Google Meet Platform on November 16, 2021, 10:00a.m through Google Meet Platform. Bids will be opened in the virtual presence of the bidders' representatives who choose to join in the online bidding.

8. The Department of Education- Schools Division of Angeles City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
